**WHEREAS**, the Walla Walla Suicide Prevention Work Group and the Department of Community Health Director join in urging citizens to learn and recognize early warning signs of suicide, and seek additional information to help further prevent the loss of lives to suicide; now therefore

**BE IT HEREBY RESOLVED** by this Board of Walla Walla County Commissioners that they hereby proclaim September as

## **“Suicide Prevention Month”**

and encourage all citizens in our county to seek information about the warning signs of suicide and prevention of suicide in order to ultimately reduce the rate of suicide in our county and nation.




**0.1% Treatment Tax – Report of the utilization of funding through December 2016.**

**August 2017**

The implementation of the 0.1% Treatment Sales Tax for Mental Health and Substance Use treatment and services has continued to generate increased annual revenue for Walla Walla County, peaking in 2016 at \$979,880.71. The RFP issued in 2015 resulted in funding to several new areas for the two-year contract period of January 2015 – December 2016. In addition to continued efforts to provide expanded mental health services provided by Comprehensive Healthcare (CompHC) to individuals without Medicaid eligibility, Comprehensive expanded services offerings in the County Jail and assumed operation of the Rising Sun Clubhouse, offering recovery support services. New and expanded services have been added in several areas in 2016, including the addition of bilingual mental health services at both Catholic Charities and The Health Center. The Health Center expanded their work to include Pioneer Middle School and Blue Ridge Elementary Schools in addition to Lincoln High School.




2015-16 Contracts were awarded through the RFP to seven agencies; Catholic Charities(CC), Comprehensive Healthcare (CompHC), Children’s Home Society (CHS), Rising Sun Clubhouse (RSCH), Serenity Point Counseling (SP), The Health Center (THC) and Trilogy (Tril) for services for a totaling of


\$1,425,940 for the two-year contract period. 2015 showed spending in excess of 50% of contract budgets. 2016 the release of a secondary funding RFP in the amount of \$100,000, resulting in additional funding to four agencies. The integration of Mental Health and Substance Use Disorder funding by the State of Washington resulted in additional funding for the SUD system, including the ability to serve individuals while in jail. As Serenity Point was able to fund Jail Services through State SUD funding, the remaining \$31,180.00 was reallocated through the RFP process to enhance additional community services. 2016 also saw the award of one new contract for Youth Recovery Support to United Way, however, the work of this contract was not completed.

2016 also saw the expansion of Therapeutic Courts, adding the Juvenile Therapeutic Court to the previously created Family Therapeutic Court.


Total expenditures through 2016:

Overall, the contracted services have achieved the following results as detailed in the Summary Report of demographic data:

A total of 7,029 persons were served, 120% increase from the numbers served in 2015.



A total of 57,376 hours of direct service was provided, representing a significant increase over 2015. This is an average of 4,781 hours/month of direct services provided by professionals ranging from Peer Counselors and Case Managers to Licensed Social Workers and Psychiatrists.

Individuals were served in multiple office locations, the Juvenile Justice Center and the Jail, schools, the Christian Aid Center and within a variety of community settings including homes, residential settings and hospital emergency rooms .

One of the targeted goals was to increase the outreach and service provision to the growing Latino population of the County. The data show that 28% of the individuals served in 2016 were identified as Hispanic and 7% identified as Spanish speakers, which is reflective of the Walla Walla demographics. This is due in large part to work of Trilogy Recovery Community in Latino outreach and the additional services at Catholic Charities and The Health Center in the provision of bilingual counseling services.

The provision of services has also reached other minority populations as 11% of services were provided to those identified as a race other than White/Caucasian.

Another targeted goal was to increase services to Youth. Overall, 40% of those served have been Youth with services taking place in several school settings as well as at Trilogy and at The Health Center locations at Lincoln High, Pioneer Middle and Blue Ridge Elementary Schools.

Catholic Charities shares the following successes:

“A single mother with three children who were experiencing homelessness came to counseling to address issues of family conflict, stress and grief. The assessment revealed that each child would benefit from individual counseling interspersed with family sessions. The children were each assigned

to a therapist and began sessions. The children were able to process feelings and develop coping skills. Counselors were able to facilitate family discussions emphasizing constructive communication, listening skills, and family unity. Family members were able to express fears and hopes and respond to each other's needs. The family has secured housing and has ended their family sessions. The children chose to continue their individual sessions. The children are performing better at school and Mom is reporting more family activities and less conflict."

Catholic Charities provided 1,521 appointments during 2016. For the entirety of 2016, Catholic Charities had an 82% kept appointment rate.

While the numbers tell us that we are exceeding our goals, the personal stories mean so much more to us. Clients come to our counseling program sometimes in the darkest moments of their lives.

The majority of individuals served in this period have been permanently housed on their own or with family. 11% have resided in a Homeless Shelter, an increase from only 8% in 2015, reflective of the great collaboration developed between Catholic Charities and the Christian Aid Center in providing a regular referral for guests of the Christian Aid Center to Catholic Charities. As mental health disorders are often a leading cause of homelessness, those at greatest risk are now being provided easy access to counseling services.

The success stories of the programs, services and agencies are clear evidence that the implementation of the 0.1% Treatment Sales Tax has had a real and significant impact for residents of the County. We entered 2017 with \$727,500 in funds obligated through a variety of contracts for direct services and are continuing to hear stories of daily successes and gratitude for access to critical services
